- Pets: all pets (dogs and cats) are to be restrained at all times, either on a leash or kept indoors and owners are to clean up after pets on common areas.
- Traffic: our speed limit is 15 mph and stop signs are located at several points. Please read and comply with the parking rules day and night.
- Construction: as a mobile home park, we are under the jurisdiction of the California Department of Housing and Community Development (HCD) and title 25 of the Health and Safety Code. Before initiating any construction of fences, sheds, awnings, etc., or exterior modifications to your mobile home, you must complete an Application for Alterations form and have it reviewed by the Architectural and Maintenance Committee and approved by the Chumash Village Homeowners Association's Board.

By signing this form, you agree to be bound by the terms and restrictions contained in the Rules & Regulations, as well as any amendments thereto which the Board of Directors and/or the members duly adopts.
